Justification for the Project

Our desire to provide information to a broad range of users as conveniently as possible is a motive behind the desire to provide online access to these materials. Digitization of Wisconsin newspapers has already been identified as a state priority. More and more users are expecting convenient, searchable, online access to these materials for their use. Our library was selected to participate in the WI Newspaper pilot project. This project is intended to set standards for newspaper digitization in WI and provide a one-stop shot through the WI Newspaper Association for researchers to access these materials. This grant is intended to help us complete a subset of our newspaper collection that will be added to the WI Newspaper Association site.

The Jefferson County Union is a newspaper that was started and edited by W.D. Hoard, an early Wisconsin governor. Mr. Hoard also started the premier dairy industry publication Hoard's Dairyman, which is still published today. The insert began in 1885 and was published as a part of the Union. Both of these publications are important parts of Fort Atkinson and Jefferson County history. They are also very important to the history of the dairy industry in Wisconsin.

The library, museum and the W.D. Hoard & Sons company all receive off-site requests for information from the Jefferson County Union and historic Hoard's Dairyman. Providing access to this information online will also make it more accessible to students conducting research in our school district. The searching capability of digitized materials enhances their value to both library staff and patrons when seeking information from these sources.

Fort Atkinson's estimated 2014 population was 12,430

Jefferson County's estimated 2014 population was 84, 395

Dwight Foster Public Library's service population in 2014 was 21,568

Estimated total circulation for the Dwight Foster Library in 2014 is 204,277

In addition to improved access to these materials our desire is to preserve them for the future.

Waukesha County Federated Library System did not receive any LSTA digitization money in 2015.

Note: the Dwight Foster Public Library and all Jefferson County libraries will be joining the Waukesha County Federated Library System in 2016 under the new library system name: Bridges.

Description:

Prep the scanned microfilm by splitting the 2-up images, cropping and deskewing them and breaking the large files into month/year/page. Run the data conversion tool. Insert captured text and metadata within the TIFF. Remake the index. Run the OCR on images. Create PDF data from TIFFs.

Evaluation:

Review samples of the completed microfilm. Run searches to determine quality of OCR and indexing.
